### **ANNEX 2: Key Program Design Considerations**

The table below outlines some of the key design and structural parameters that should be considered for programs seeking CDG funding. Given the flexible, non-prescriptive approach of the CDG program, applicant organizations may consider their own experiences and strategy, but should adhere to the general guidelines and all compliance-related areas.

#### Program Structure(s)

CDG recipients should be programs set up to address financing needs for startups, early-stage firms and SGBs. The structure of the program could take various forms, such as:

- A traditional venture capital fund or an open-ended fund
- An angel group/network
- A syndication approach whereby a lead investor is pooling investments from a select network of co-investors
- A blended approach combining a small/micro fund with deal-by-deal syndication
- Another appropriate structure that enables the program to fulfill its objectives and that best aligns with Iraqi/regional legal structures.

The guiding principle is that the program model should seek to mobilize private investor capital, with a priority, though not necessarily the exclusive focus, on local and regional, and diaspora investors (as well as institutional investors). The CDG should be seen as a levering tool to attract investors by supporting the establishment of a professional structure, building management capacity, developing investment processes, increasing transaction know-how and building a track record by completing an initial set of investments.

CDGs will target organizations with evidence of a long-term strategic commitment (i.e., minimum 8-10 years) to start-up/early-stage finance Iraq.

# Institutional Arrangements & Management / Governance

The CDG recipient must be an independent operating entity operating in Iraq, with a local management presence. The program arrangement could include an Iraqi-registered management company, with a physical presence in Iraq, that supports an offshore investment fund.

Recipients will need to have management and governance structures commensurate with the sophistication, objectives, and approach of the investment program along with the amount of the CDG grant. This may include:

- An independent and dedicated management team that has/is developing the experience to build and manage a pioneering earlystage investment program and portfolio and can grow the program by bringing in additional investors/funders.
- Capacity to meet the fiduciary and funding requirements associated with GIZ and World Bank grant funding.



Investment Objectives, Focus and Approach	The expectation is that CDG programs will focus on startups, early-stage firms and SGBs and will seek to develop investment theses and approaches that strive for commercial returns commensurate with the risk associated with early stage investing in frontier markets. The program should seek opportunities for investment that have commercial viability and can provide credible opportunity for realizing financial returns for investors through equity or quasi-equity structures.
	Programs should focus on startups, early-stage firms and small and growing businesses (SGBs) with significant potential and ambition for growth. They can operate in any sector, utilize innovative / technology-based business models or more traditional ones, and/or be at different stages of development.
	It is expected that the approach will include the management team and/or participating investors being hands on in business building, market development or subsequent capital raising assistance to support investee companies, by working closely with the investee companies to advance each company's viability and commercial success through a clear exit strategy.
Deal Size	Deal size may vary depending on the investment thesis of the firm / program, investors involved, the company receiving investment and chosen investment structure.
Instruments	As it is anticipated that CDG recipients will be funding early-stage firms in the initial stages of development and funding growth, it is likely that programs will be deploying equity or convertible debt instruments. Additional approaches including other structures such as venture debt or revenue share may also be considered.
Economic / Sustainability Model	The recipient must demonstrate a strategy and economic model that will enable the program to sustain itself beyond the CDG.
	Variable funding provided by the CDG will emphasize (and reward) tactics and indicators that contribute to this aim and proposals should include a plan and financial model outlining the approach to achieving operational viability. This includes areas of technical and operational capacity development (management, team and investor skills and experience, e.g.) as well as income generation.
	Depending on the objectives of the program / firm revenue sources and clientele could evolve over time to include public sector support, membership dues / fees, services, sponsorship, etc.

## **ANNEX 3: CARP Project's Exclusion List**

The WB has classified 14 areas of business involvement that are exempted from funding from this Project. Together, they form the basis of the CARP Project's exclusion list. The following type of activities are ineligible for financing under this Project:

- 1. Production or trade in any product or activity deemed illegal under Iraq's laws or regulations or international conventions and agreements
- 2. Production or trade in pharmaceuticals, pesticides/herbicides, ozone-depleting substances, polychlorinated biphenyls (PCBs) subject to international phaseouts or bans
- 3. Trade in wildlife or wildlife products is regulated under Convention on International Trade in Endangered Species
- 4. Production or trade in weapons and ammunition
- 5. Production or trade in alcoholic beverages
- 6. Production or trade in tobacco
- 7. Gambling, casinos, and equivalent enterprises
- 8. Production or trade in radioactive materials (this does not apply to the purchase of medical equipment, quality control measurement equipment, and any equipment where the radioactive source is considered to be trivial and/or adequately shielded.)
- 9. Cross-border trade in waste and waste products, unless compliant with the Basel Convention and the underlying regulations
- 10. Production or trade in or use of unbounded asbestos fibers
- 11. Unsustainable fishing practices, such as drift net fishing in the marine environment using nets in excess of 2.5 km length, electric shocks, or explosive materials
- 12. Production or trade in wood or other forestry products other than from sustainably managed forests
- 13. Production or activities involving harmful or exploitative forms of forced labor or harmful child labor
- 14. Activities involving land acquisition and/or restrictions on land use resulting in involuntary resettlement or economic displacement
- 15. Any activities involving significant degradation or conversion of natural and/or critical habitats and/or any activities in legally protected areas
- 16. Production, trade, storage, or transport of significant volumes of hazardous chemicals, or commercial scale usage of hazardous chemicals (gasoline, kerosene, other petroleum products, textile dyes, and so on)









- 17. Production or activities that have adverse impacts, including relocation, on the lands, natural resources, or critical cultural heritage subject to traditional ownership or under customary use by Indigenous Peoples
- 18. Activities involving significant adverse impacts on critical cultural heritage
- 19. Production or trade-in or use of non-biodegradable packaging material such as polythene bags and Styrofoam.


